On Saturday, August 15, the Hot Nights Cool Rides Car Show will be held on historic Main Street from 9AM-8PM. Take a stroll through the hundreds of cars parked down Main Street, visit our local shops and boutiques, grab a bite from our restaurants or food trucks.

From 9AM-5PM, stop by POPS to check out the Pit Road Vendor Alley featuring local vendors, including local artists, crafters, boutiques, retail businesses, specialty product vendors, nonprofits, community organizations, and other family-friendly vendors.

Admission is free to the public. Vendors for the Pit Road Vendor Alley will set up inside POPS. There is a \$50.00 fee for vendors to participate.

Guidelines:

- **Cannot be a food or drink vendor.**
- All vendors and their associates are responsible for following the guidelines.
- No vehicles are allowed on the pavers or inside the park at any point. Please let Arianna know in advance if you will need assistance loading/unloading.
- Booth spaces are 10' x 10' - location is determined by the Hot Nights Cool Rides Committee.
- Vendors accepted for participation in the show must be in attendance during the event.
- Vendors must supply their own tent, tables, chairs, display materials, etc. **Electricity is not provided.**
- No generators or loud sound systems are allowed.
- Vendors must stay open to the public until 5PM.
- The festival is held outdoors, rain or shine.
- Bring plenty of business cards and promotional materials.
- Keep your exhibit open for access by visitors by carefully positioning potential barriers such as tables and displays.
- It is never too early to start planning for this event. The day will sneak up on you if you are not careful! Try to make the display colorful and exciting and have fun with the theme.
- Your signature on the Application Form constitutes an agreement to be bound by the stated policies.
